Step Four of AA's Twelve-Step Program of recovery is infamously the “scary” one, probably because it's a crucial step towards effective and lasting recovery. Since the overall philosophy of Alcoholics Anonymous is that alcoholism is just a symptom of a spiritual disease, the real problem is in character flaws that need to be faced and when possible, overcome.

This requires a searching, bare it all revelation-inducing inventory that will become the blueprint for your success.

The benefits of completing Step Four are strengthened sobriety, spiritual growth and movement towards mending your relationships to your HP, yourself and other human beings. What's the biggest requirement for this action step? Be honest! You and the people around you will benefit from this crucial step. In case you didn't know, keeping secrets is threatening to our recovery, and we have all had secrets that nearly killed us. Our secrets, in and out of sobriety, keep us sick.

Almost everyone comes into recovery having trouble separating fact from fiction in our own lives. The reality is that the “drunkalogues” and war stories that accumulated over the years of using are so embroidered into the fabric of whom we think we are. However, while working on our step inventories we get a new perspective on the bigger picture, on patterns, selfishness, our responsibility in situations and in this process we are building up an accurate self-appraisal with true self-worth as the reward.

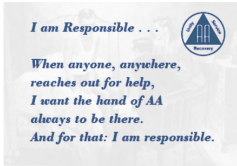
"Step Four is our vigorous and painstaking effort to discover what these liabilities in each of us have been, and are. We want to find exactly how, when, and where our natural desires have warped us. We wish to look squarely at the unhappiness this has caused others and ourselves. By discovering what our emotional deformities are, we can move toward their correction. Without a will and persistent effort to do this, there can be little sobriety or contentment for us. Without a searching and fearless moral inventory, most of us have found that the faith which really works in daily living is still out of reach."

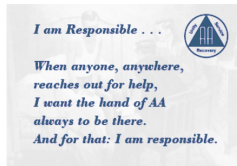
Courage kicks into overtime as we write down our deeds without fear. Fear of retribution, fear of vindication, fear of reprisal, fear of being exposed for what we really are: big, fat phonies. The disease had created these great masks of bravado, coping mechanisms or survival skills to bring us to this point of recovery. The Fourth Step exposes these “skills” for what they really are: character defects. An inventory is, just like any good retailer will tell you, taking stock of what's selling and what's not. In this case, a moral inventory is taking stock of what's working for us and what is no longer useful in our new lives.

The Fourth Step is actually one of the kindest and loving things we can do for ourselves. We must remember this is not a bat to beat ourselves up with, but to be gentle and kind with ourselves during this process of “discovery” and not give up. We go to meetings, we share our fears about this step and they are lessened. We light a candle, say a little prayer “to be Searching and Fearless,” and we move forward out of the dark into the Light.
