Step One and Surrendering

Step one is where it all begins. It is important for people to spend as much time as they need to work each step. You want to process it fully, understand it, and apply it to your life. You might be wondering, "How do I do step one?" There are several ways that you can do step one correctly so that you can get the most out of it and utilize it as the foundation of your recovery.

The steps, while the same across the board, are subjective to each individual. This means that one person might go about completing step one in a different manner than another person. That is completely acceptable, however, it is important that when finished, individuals know their powerlessness over alcohol and surrender to the disease. Some ways to get to that point in step one can include the following:


- **Break down denial.** It is likely that you have spent a great deal of time telling yourself and others that you did not have a problem with alcohol abuse. You might have even said it so much that you got yourself to truly believe it. You might even realize, for the first time, that you did have a problem as you begin the steps. Either way, it is imperative to break out of the fog of denial by looking around and assessing your relationship with alcohol. Doing so can help you get a grip on reality so that you can go forth in your truth.
- **Split the step into two parts.** Look at step one as 1) admitting that you are powerless over alcohol and 2) that your life has become unmanageable. Focus on the first part until you are comfortable in saying that you are powerless over alcohol and believe it when you say it. Then, take the time to look at your life and experiences with an aerial view so that you can see the big picture of how unmanageable it was.
- **Let go of ego and focus on humility.** Try at least once to let your ego go out the window and adopt humility. This can be much harder than it sounds, especially if you are used to letting your ego run the show. The sooner you find ways to humble yourself, however, the more open you can be to step one and the rest of the steps.
- **Place feelings of guilt and shame on the back burner for now.** These feelings are so incredibly common, however, they can get in the way of you making progress in your recovery. Do not try to push these feelings down and try to forget them. After all, doing so will only stand in the way of your recovery. But, allowing them to "live" somewhere else while you focus on step one can help avoid distraction and emotional upset that can challenge your progress.

How You Can Make Step One Easier to Accomplish:


When you start to fully immerse yourself in the 12 steps, you may experience a number of different emotions. There is nothing light and breezy about step one. Instead, it is often viewed as one of the most difficult steps to accomplish. After all, it requires admittance of having a problem. However, when you do step one, there are things you can do to make it easier. Some of the most important things you can do when working the first step can include the following:

- **Get a sponsor.** A sponsor is someone who has accomplished several or all of the 12 steps. They will be able to provide you guidance and support as you begin your own personal journey with the steps. The first sponsor you choose does not have to be permanent. After all, you may decide to ask someone else to sponsor you after you have gotten to know more people. Your sponsor can not only offer you support, but also give you insight on how to own the first step.
- **Go to meetings.** The vast majority of people who have attended a professional treatment program have been exposed to the 12 steps. However, many of those same individuals don't really begin diving into the steps until they start going to meetings. Not only do meetings help immerse you in the steps, but it also helps to hear the experiences of others. As a result, you can gather strength, confidence, and perseverance for your own journey.
- **Make the most of your time spent in 12-Step meetings or groups.** Whether you are in treatment or in recovery, you can make the most of your time by fully engaging in 12-step meetings. This can include ensuring that you are paying attention, sharing, asking questions, etc. The more involved you are in your meetings or groups, the easier it will be to accomplish your steps.

There is no specific way to do step one, as every person struggling with alcoholism is different. The most important thing you can do when working step one is to remember the goal of the step. Do what you can to fully absorb the meaning of the step, and take action that will help you to surrender.

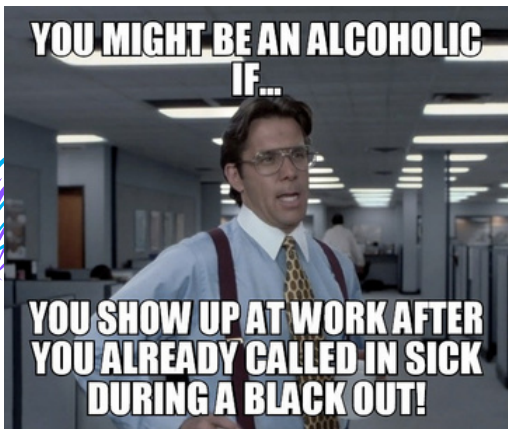

From the Desk of Lisa F- District 14 Treasurer

In order to be better stewards of Alcoholics Anonymous' District finances, a Budget Subcommittee was formed at the December meeting of the District 14 General Service Committee. The intended purpose of the committee was to:

1. Decrease operating expenses to less than \$14,000 and
2. Increase our Prudent Reserve (financial safety net) to 9-12 months of funds



In order to continue to support the District 14's functions of fostering unity of AA in our district (Santa Rosa County, Okaloosa County and Walton County) and of serving groups and individuals as they help carry the message to the still suffering alcoholic, we need to ask for your help in keeping "bare running expenses and maintaining a prudent reserve."

As we pare down the budget, see attached table, we also need to look down the road to the effects for 2025 and beyond. Our current 2024 budget of \$13,862 (if approved) is not sustainable for 2025 at the current level of contributions. As a committee, we decreased the budget by \$2620. There were some tough decisions, especially the removal of scholarships to Area Assembly for GSR's. This had been a cost of \$1000, but in keeping with the Seventh Tradition, the committee felt this cost should be returned to the group level. Multiple committees and district positions saw reductions to their budgets, as well.

Of significant need is accruing \$10,397 - \$13,862 (9-12 mos financing) in our prudent reserve. We currently have only \$1,516 or approximately a 1.5 month prudent reserve. This accrual we will do over time. Lesser months' prudent reserve was acceptable pre-pandemic, but in our post-pandemic environment, new guidance has emerged out of the tough experiences from groups, districts and the GSO. District 14 will begin by allotting \$100/month to the prudent reserve account.

We realize this is only a little, but it is a starting point. The next frontier in building our safety net is to ask AA groups to consider regular, consistent contributions to include District 14. We do have some regular, consistent contributors to whom we are most grateful. Even if a regular contribution is small, being able to count on the steady stream of funds to build our prudent reserve would be extremely helpful.

Back in 1939, the Big Book mentioned folding paper money, meaning a dollar, being offered in the basket at meetings. Here we are nearly 85 years later still doing the same thing. I can't even imagine how much inflation has impacted that dollar bill-needless to say, it is a huge impact. If you are able, as an individual AA member, please consider increasing your offering at meetings. And, as we always say, if you are not able to contribute, don't worry about it. We rely on you and your General Service Representatives (GSRs) for your service and financial support to bring the news of AA as a whole to your group and to bring the voice of the group to AA as a whole.

A little about Corporate Poverty, a value that AA utilizes at all levels. Going forward we must:

1. Be true stewards of AA's finances
2. Act as if poor, even with an acceptable prudent reserve
3. Not increase spending above ordinary amounts unless the Fellowship (by votes of the GSRs) clearly indicates a desire for new services. ("Corporate Poverty" The AA Grapevine March 1997)



When thinking about AA finances it is important to remember the spiritual benefits of contributing.

1. It is as important to the contributor as to the recipient.
2. It gives groups an opportunity to know they help to carry the message around the district - in treatment facilities, jails & prisons, to professionals, through literature and Grapevine circulations and through your DCM and Alternate DCM.

Corporate Poverty, like powerlessness, is a GOOD thing! Don't let the word "poverty" dissuade you; it is merely a detachment from money in a spiritual sense. It is a state of mind. And also, fiscal common sense.

Thank you in advance for your thoughtful consideration of this information.
