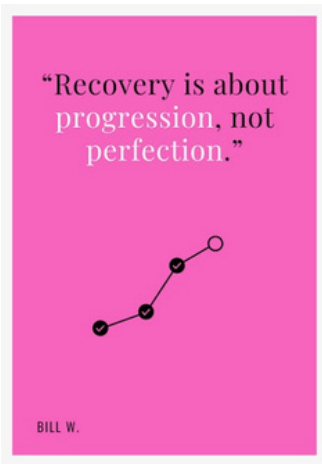

The breakfast was a smash, I encourage everyone to come out, they get better monthly.

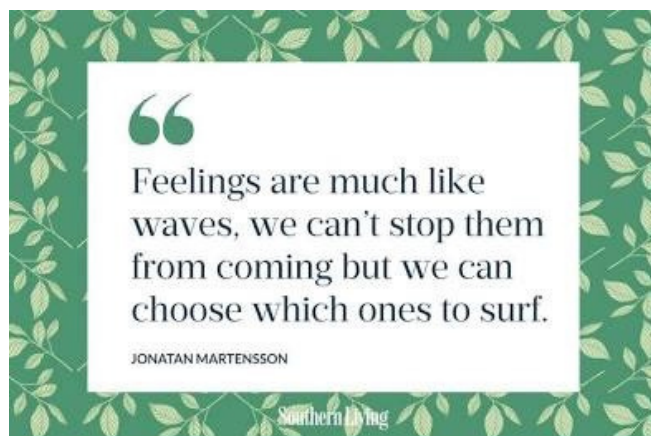
The Eat and Speak was really good, and look for some changes coming down the pike

• **SECRETARY** (Suji G) Read abbr. June 16, 2025, minutes. Copies distributed. Motion to accept as read, approved.

• **RELOCATION AD HOC COMMITTEE** (Suji G) Read abbr. June 23, 2025, minutes.

Copies distributed. “The most important of June 23rd ad hoc minutes is to take back to home-groups to please increase 7th Tradition contributions to Intergroup/Central Office and to announce our new location.” Motion to accept as read, approved.

Motion to accept report. Seconded and approved.

• **IG CHAIR** (Jamie L) He attended July 6th IG Breakfast hosted by Unity Group. “Leah S. was the speaker and did a really good job! We had a really good turnout!” Jamie thanked IG Breakfast team for their fantastic service. He had a great time at June 28th Eat & Speak hosted by Buster’s for Sobriety. A.A. Speaker was Mark K., and Al-Anon Speaker was Laura M. Jamie thanked Rick V. and everyone who helped with efficiency of set-up and break-down. Jamie shared, he decided to not attend July 11-13th Area Assembly, “I’m not going to go back to Area Assembly until I feel like there’s a reason for me to go to Area Assembly, because I really think it’s more important right now that we don’t put \$300.00 in my pocket to go there. I don’t even have a vote there. So as much as I like going, I’m just not going to go.”

• **IG ALT-CHAIR** (Suzie B) She attended June 28th Eat & Speak and July 6th IG Breakfast. Suzie attended July 11-13th Area Assembly’s Intergroup Committee meeting. The Chair spoke of not having stipend for Area Assembly. There was lengthy discussion, and an Area Delegate explained why we do not have stipends. According to 2024 revised edition of The A.A. Service Manual (BM-31), Intergroup is not in the guideline of Area Assembly. “So, it was just a service created for Intergroup’s to come together and share information about Intergroup. So, we made a motion to table it, so she will have time to go out and get some information from the other Intergroup’s in the area.”

Passed –Motion to add Gold Key, Franciscan, and Volunteer Action awards to the already published Lasker Award in the BB. Consideration is to add text to guide readers to AA.ORG for more information. – Recommended GSO pause renovation until plan to replenish GSO prudent reserve to nine months. It did not pass. Area One is currently working on a Post- General Service Conference “report.” Also, there is a Preconference survey available seeking feedback to improve the process. Follow up to what became of the Area’s Districts input. GSO The Contribution address has changed at GSO. As a result of the work of the Location Plus Committee of the General Service Board, it was decided that GSO will continue office operations from our current location at 475 Riverside Drive in New York. It was also decided to consolidate GSO operations on the 8th and 11th floors to the 11th floor only. Thus, realizing savings in occupancy costs and allowing for better collaboration and effectiveness among all departments and services we provide. The GSB Committee in Cooperation with the Professional Community/Treatment and Accessibilities is launching the “Military Veteran Interview Project” to enhance outreach efforts tailored to military veterans. - **WEB SERVANT** (Bobby C) Did a good scrub of updating addresses and numbers. Uploaded new flyers. "If there's anything that you see that needs correction, please bring it up and I can correct it on the spot." o There was discussion of process to update address in Google. Jamie stated he believes new address will automatically transition in about five to seven business 5days after having updated our address with USPS a week and half ago. Bobby and Jamie will stay updated on the process. o Addresses have been changed on the meeting guide app. Johnnie C. inquired if address of "Building A" has been uploaded. Bobby and Jamie will double-check.

### **OLD BUSINESS**

- Jamie L (IG Chair) "The lease was signed, and the move was successful." He contacted NBI and they are mailing us \$100.00 security deposit. Jamie thanked Jennifer G., Brad A., Suji, Bobby, and everyone who helped leave our old location nice and everybody who helped move Intergroup/Central Office. Brad A (DCM) expressed his gratitude to Jennifer G. for all her hard work during the move. • As reported on June 9, 2025, Relocation Ad Hoc Minutes and on June 16, 2025, Intergroup Minutes, unfortunately we are locked into a 3-year COX contract, ending on Aug 2026. Jamie called COX on June 26th and found; we are under a promotional rate that was due to run out at the end of June. We would have seen a significant increase of \$89.00 per month. He was able to have this promotional rate renewed for another year so, our COX bill will remain the same. • We are under move budget of \$1,000. We spent roughly \$799.00, and some more will be spent as well as, some money will be returned. Jamie had 30 keys made for \$107.00. There will be costs to replace some lighting. The storage facility kindly refunded near half of cost. • As per District 14 Intergroup/Central Office Inc. bylaws, Jennifer G (Book Fund Chair) has determined paying Intergroup \$500.00 monthly rent for July, August, and September. In September, she will review Treasurer reports for July, August, and September to determine rent amount. It may go down to \$400.00 monthly based on Intergroup funds.

### **NEW BUSINESS**

- Jamie L (IG Chair) raised topic of District Committee possibly increasing their quarterly \$450.00 rent to Intergroup based on prior discussion with Brad A (DCM) of providing District with an increase amount to work toward. o Suji G (IG Secretary) and Jamie L (IG Chair) came up with reasonable increase amount of \$100.00 quarterly for Brad to please take back to District for

*New business continued...* discussion. Brad agreed \$100.00 quarterly increase is a fair amount. Suzie B (IG Alt-Chair) made a motion for Intergroup Committee to approve Brad A (DCM) to bring request of \$100.00 quarterly rent increase to District Committee. Motion was seconded by Rick V. There was discussion. Michael M. asked what the reason is for asking District for rent increase. Suji G. explained, Archives room belongs to District, and it now takes up more real estate at new location. There was discussion. Rick V. referenced June 16, 2015, Intergroup Committee minutes, "I just read here that District is facing a probable deficit?" Brad A (DCM) replied "We're definitely going to go back and ask the question, and we'll go from there." There was discussion. Amber H. inquired, with the increase of rent at our new location is an increase of \$100.00 on par, the same scale of rent? Jamie replied, we went from \$730.00 to \$1,300.00 so, no it is not on same scale and Intergroup is just asking District for help. Pat M. added, Intergroup rent doubled and asking District for \$100.00 quarterly increase is not doubling their rent. Vote on motion for Intergroup Committee to approve Brad A (DCM) to ask District Committee for quarterly rent increase of \$100.00. 9 in favor, 1 opposed. Minority voice, Johnnie C. stated, "I don't think we should be asking District for more money at this time because this has been said a couple of times, they're probably facing a deficit, and we don't really need it." Elizabeth P. stated, "I feel like \$100.00 is just kind of pulled out of the air, that we have no backing of the exact this is what it will be and what it will cover. I think it needs to be more precise before we give them a number." Pat M. asked what our current rent is. It is \$1,300. Pat M. also asked what the current rent for District is. It is \$450.00 quarterly. Pat M. asked if District Committees use Intergroup location for their meetings and if Archives has an entire room. Yes they do. Michael M. asked if \$450.00 is the rent District paid in old location. Yes it is. Jamie asked Elizabeth to please elaborate on precise \$100.00. Elizabeth stated, "How did you come up with it." Suji G. explained a reason for District rent increase, "Archives room at prior 24 Hollywood was not being paid for because they didn't know and now, it's a whole room and taking up real estate." Suzie B. further explained that when Intergroup first started, the whole committee belonged to Intergroup till a DCM said the Service Committees belong to District. The Service Committees moved to District except the Archives kept Archives at Intergroup. "That is why they thought it was always a part of Intergroup. But the thing is, Archives is not a part of Intergroup, it's part of District. So, that's why it has been going on for all this time. I can see where Suji came with the idea because it takes up a whole room over here in the \$1,300.00 that we are paying now." Johnnie C. stated, "We took up a whole room over there also." Johnnie gave District's quarterly cost breakdown, \$354.00 rent, \$75.00 for copies, \$24.00 for Zoom. "So, they've paid rent on something. What did they pay rent on if it's not the Archives room?" Suji G. replied, "Meetings and storage. All the District Committee Chairs have keys to come and do their meetings with Zoom access and all that." Rick V. asked why we are bringing up District rent increase now considering groups have donated and we are financially okay now? Jamie replied, "That's a snapshot of our bank account today." Pat M. added, "24-hour news cycle." Pat M. further shared for everyone to please take back to home-groups that this is the year 2025 and the cost of one dollar in the basket has changed, "There's absolutely nothing you can buy in a dollar store for a dollar anymore. We really need to change this culture of a dollar or we're not going to survive." Jamie stated we have only made one rent payment, and our rent has doubled so, a picture today is



*New business continued...*not going to be our picture in 6 months. Jamie further shared, "It's just a simple request. Take it back. We're okay if you say no. We're asking because we're thinking forward." Revote on motion for Intergroup Committee to approve Brad A (DCM) to ask District Committee for quarterly rent increase of \$100.00. 7 in favor, 4 opposed. 2/3rd motion passed. • Jamie L. asked we think about ordering new street signs for new location as any direction to our new location will be beneficial. Aaron N. volunteered to take down old street sign however, he found others bolted their signs to our sign. Jamie will contact NBI. Suji G. will proceed with laminating sign for door once power is back on. • Jamie gave Tom W (Deckhands Group) a shout out for great idea of considering a low-cost open house day. There was discussion and in agreement to first finish setting up Intergroup and to have in fall season. • There were discussions of changes to quarterly Eat & Speak. Examining new ideas, future hosting group stipend of \$275.00, Tradition Five and Al-Anon participation, Tradition Seven and Al-Anon basket donations. Brad A (DCM) suggests for the sake of unity, to take ideas back to home-groups instead of a select few discussing. Rick V (Eat & Speak Chair) made motion to table all mentioned discussions of changes to Eat & Speak till next Intergroup meeting. All in favor, none opposed. Motion passed.

### *The Long Form Version of Tradition 6 in AA*

*AA has a long-form version of all its traditions that explains each in more detail. Here's the long form of Tradition 6:1*

*"Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A. - and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one."*
