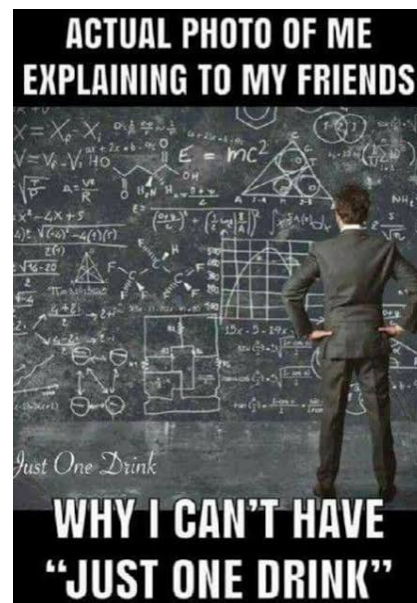

Jamie hopes to see more attendees next month, “Sure would be nice to see all you guys that have been coming back. OLD BUSINESS

Motion to take back to home-groups to keep Eat & Speak dual-purpose or change to singleness of purpose meeting which includes, 7th Tradition basket contributions. Lynn A., Community Group in Mossy Head, voted to keep it the same with the exception of adding a statement to the format that the 7th Tradition contributions be added by only A.A. members. Amber H., “That was mirrored by An AA Group too.” Jason L., “Early Risers, ditto.” Joe S., “Third Tradition, the same thing.” Deb B., “Living Sober Group, same thing.” Natasha G., “Navarre Fellowship, same.” Bobby C., “Happy Hour Group, the same.” Michael M (Miracle Group) reported they had a group conscience on the motion. Seven members in favor that the Eat & Speak is breaking traditions five, seven, and three. One member was opposed to that. “So, we were actually against it but, not getting rid of it altogether.” Miracle Group discussed having a separate committee like Summer Serenity at the Beach or a Roundup that has its own entity and is not connected to A.A. Amber H. motioned to keep Eat & Speak as it is with the exception of changing the verbiage of 7th Tradition contributions by A.A. members only. Substantial unanimity in favor, one opposed. Jamie L. gave Michael M (Miracle Group) the floor for minority voice. Michael M. stated he is bringing the group conscience that they see that dual-purpose breaks Tradition Five’s singleness of purpose and Tradition Seven and self-supporting. Michael further stated, he personally gets a lot out of the Eat & Speak and enjoys listening to Al-Anon and it is a way to unity for him. Michael hopes he did not bring the wrong question to his group as he was not present for August 18th Intergroup meeting. The question he brought to Miracle Group was, “Does it break any traditions?” Seven group members agreed Eat & Speak does break traditions and one was opposed. They think it is a great meeting and camaraderie, good for A.A. but, is it necessary for Intergroup to fund something that is also going to Al-Anon and Al-Anon funding something that is A.A.? There is concern this may be opening the door for N.A. and Gamblers Anonymous, etc. “Overall, we think it's a good thing but, yes, we think it's breaking the traditions.” The motion to keep Eat & Speak as it is with the exception of changing the verbiage of 7th Tradition contributions by A.A. members only, carried with substantial unanimity. Suji G., volunteered to create “7th Tradition contributions for A.A. members only please” signs for Eat & Speak, approved. Rick V (Eat & Speak Chair) will change format verbiage.

NEW BUSINESS

Jamie came up with four possible options for Oct Intergroup Breakfast and welcomes hearing other options. 1. Do not have the Intergroup Workshop because it is a nonvoting year and have Intergroup committee Speaker(s). 2. Have it second Sunday (Oct 12th) with no breakfast and Intergroup Committee Speaker(s). 3. Cancel the breakfast all together and have an Intergroup/Central Office low cost "Open House" event @ 4 9th Ave, Building A, Suite A, Shalimar, FL 32579. 4. Not do anything for the month of October. Jamie stated, if we steer away from the workshop, which was driven by voting, that we do not need to skip the first week because we could still do a Speaker breakfast without entire Intergroup committee present. There was discussion. Rick V. raised the likelihood members who consistently attend IG Breakfasts will not be aware of date changes. Rick likes the idea to keep IG Breakfasts on normal first Sundays of October and November months and to have Open House event on another date. Suzie B. agrees with Rick, "Alcoholics don't like changes. I know some elderly people make it a purpose to come to the breakfast so, I am with Rick. It's not about us. October 5th is next monthly Intergroup Breakfast hosted by Intergroup Committee, Speaker(s) TBA. \$8.00 buffet breakfast @ 9:30am and Speaker @ 10:30am. Located @ Amvets Post 78, 910 Valastics Ave in Valparaiso, FL 32580. (NOTE 9-19-25 Speakers will be Jamie L., and Elizabeth P). Elizabeth P. asked to keep November IG Breakfast on the 2nd and to have \$100.00 to provide attendees donuts and juice. Amber H. motioned to keep IG Breakfast on November 2nd and \$100.00 stipend to provide donuts and juice. Janna K. seconds. All in favor. Motion carries. Open House: Rick V. withdraws motion to host both IG Breakfast and Open House. Suji G. stated November and December are holiday months so, October really is the optimal month to host an Open House. "This spanned back from our move here, we just wanted to say thank you. It will be a low-cost event and family, and children are welcome. We'll make it very children friendly." Suji G. referenced GSO's Use of the Circle/Triangle Symbol (SM F-113) which states, "Consistent with A.A.W.S.' original purpose in protecting the circle and triangle mark, that is, its desire to avoid the appearance of association or affiliation with outside goods and services, A.A.W.S. phased out its own "official" use of the circle and triangle symbol on, or in connection with, its literature and other materials, and its services." Suji stated, "They tried to reel it in, but they can't, because we still use it on t-shirts and everything like that. My concern is, it's not an official A.A. thing and Intergroup is a corporation. So, it is kind of considered like an outside enterprise. It's weird because we serve A.A., but we're not A.A. I know we had the circle and triangle on the street sign before, but after reading that notice, I thought twice about it." Johnnie C. inquired if the existing wooden "District 14 Intergroup/Central Office" sign currently positioned sideways in the Book Fund room window will be mounted to the exterior wall. Jamie suggested Johnnie may secure the sign to exterior wall during his upcoming Friday office shift.

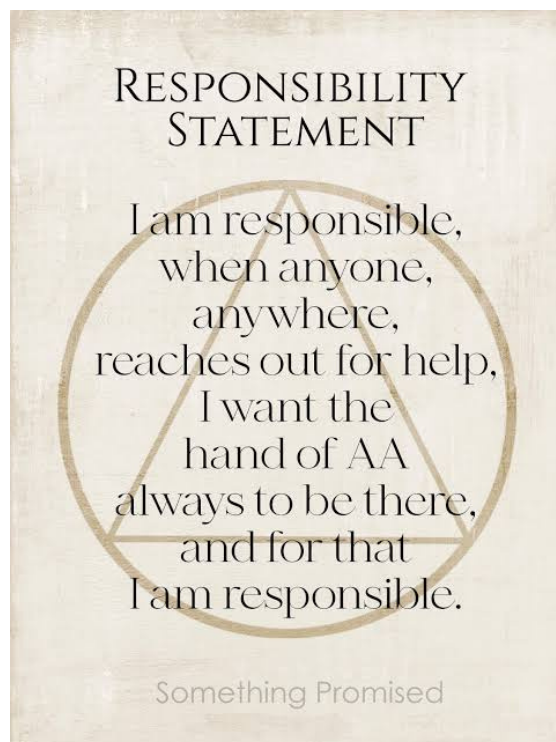

The Long Form Version of Tradition 6 in AA

AA has a long-form version of all its traditions that explains each in more detail. Here's the long form of Tradition 6:1

"Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A. - and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one."
